Southeast Asia's AI infrastructure is expanding rapidly, with data center capacity projected to triple by 2030, reaching between 5.2 GW and 6.5 GW, driven primarily by AI workloads. Malaysia and Indonesia are emerging as key anchors of this ASEAN compute belt. Malaysia's Johor region alone hosts multiple hyperscale campuses, including AirTrunk's USD 3 billion investment for JHB3 and JHB4 totaling 280 MW, and Princeton Digital Group's JH1 and JH2 with 370 MW. Indonesia serves as an overflow market for non-AI workloads displaced from Singapore and Johor, reflecting a regional distribution strategy.

National AI Strategies



All 10 ASEAN member states have developed national AI strategies, aiming to boost productivity, create jobs, and enhance digital skills among their populations . Countries like Singapore, Vietnam, and Malaysia are attracting R&D and cloud infrastructure investments, while Indonesia and the Philippines leverage large domestic markets to pilot AI-driven services . These strategies are complemented by a light-touch regional governance framework, allowing flexibility while promoting responsible AI adoption .

Governance and Ethical Frameworks

ASEAN has established the ASEAN Guide on AI Governance and Ethics, which provides principles for the ethical design, development, and deployment of AI systems . The guide emphasizes transparency, explainability, and responsible use of AI, including generative AI, while allowing member states to implement policies according to their digital maturity . Countries are encouraged to conduct AI risk impact assessments and adopt proportionate explainability measures to ensure trust and accountability.

Investment and Economic Impact

The region is attracting significant investment, with total data center investment expected to reach USD 30 billion by 2030, growing at roughly 20% annually . AI adoption is expected to enhance productivity across industries such as healthcare, financial services, retail, and e-commerce, creating opportunities for low- and middle-income populations to acquire AI skills and transition to higher-paying jobs . The youthful, tech-savvy population of over 200 million people aged 15–34 provides a strong foundation for AI innovation .

Regional Collaboration

ASEAN countries are also engaging in regional and international cooperation, including memoranda of understanding with China on digital technology and AI, while maintaining a balance with global partners to address cybersecurity and national security concerns . Working-level follow-ups focus on technology education, mobile networks, and AI infrastructure development.
