When an EMS shipment shows a “Departed From Export Office” status, it means the package has cleared customs in the origin country and is now in overseas transit via a line-haul operator such as an airplane or cargo ship . During this stage, tracking updates may pause until the package reaches the destination or a transit country, which can give the impression that the shipment is not moving, even though it is progressing . EMS public tracking requires a valid tracking number, and leaving this blank will prevent updates from being displayed .

Anti-Tracking Considerations

While EMS does not provide a built-in “anti-tracking” feature, organizations concerned with privacy or sensitive shipments can manage visibility by controlling who receives tracking numbers and by using export compliance systems to monitor shipments internally. Limiting public access to tracking information and using secure internal portals can help maintain confidentiality.

Export Compliance and Management

For organizations exporting goods, an Export Compliance Program (ECP) ensures adherence to regulations such as the Export Administration Regulations (EAR). Key elements include senior management commitment, proper documentation, and procedures to classify products, screen parties, and track licenses . Automated Export Management Systems (EMS software), like e2open, can classify products according to Harmonized System (HS) codes, screen restricted parties, track licenses, and store critical trade documents . These systems also help organizations comply with evolving regulations, reduce export risks, and maintain internal control over shipment visibility.

Best Practices

- Use export management software to automate compliance and track shipments internally.
- Control access to tracking numbers to prevent public visibility of sensitive shipments.
- Monitor EMS updates to understand shipment progress, especially during overseas transit.
- Maintain proper documentation for licenses, exemptions, and end-user statements to comply with export regulations . By combining EMS tracking with robust export compliance systems, organizations can ensure shipments are both efficiently monitored and securely managed, minimizing regulatory risks while maintaining operational control.
