- **Exit Chamfer:** A beveled edge that prevents excessive bending of the fiber during crimping, reducing the risk of transmission gaps or fiber breakage . During installation, the fiber is placed between the clamp members, and the housing is crimped. This action locks the fiber securely while minimizing stress or bending, which is essential for maintaining optical performance .

- **Jacketed Stub Terminations:** Where a short fiber segment is pre-terminated for patching.
- **Buffered or Pass-Through Terminations:** For both indoor and outdoor fiber installations.
